
TPEA members have significant experience in eTwinning and can advise on a variety of methods of using digital technologies to support global collaboration and learning.

Privacy is our right to decide what information we share & who we share it with. When we use technology, it sometimes can be difficult to see who has access to things we have saved or posted online.

Just like in the real world, our personal information is extremely valuable. By ensuring our privacy, we remain safe & help protect family members & friends.

Ways to Be Private

- When I'm online, I protect my identity by keeping personal details private.
- Whenever I'm asked to provide personal details, I carefully consider if this is legitimate & the consequences of oversharing information.
- I know how to check my privacy settings on social media platforms & social entertainment apps. I routinely check these to ensure they are at a safe/high level.
- I know how to check my apps & device location settings. I only share my location with my trusted friends and parents/guardian.
- I only share with contacts who I trust. If I am unsure of the identity of a request, I decline or block & inform a trusted adult.

Being respectful is being considerate & lawful. This helps us to keep a positive digital reputation & protects us from experiencing negative consequences in the real world.

Ways to Be Respectful

- ✓ I observe the legal age requirements for apps & social platforms. I understand that technology is a privilege not a right.
- I value other people's privacy & take care not to share-on personal details or content intended only for me.
- Even if I disagree with other people's beliefs or opinions, I choose to be considerate rather than hurtful.
- I understand the difference of copyrights & copywrongs. I know how to stay within the legal & ethical dimensions of respecting other people's work.
 - When I use technology, I am careful not to disturb others or appear distracted by my device when engaging in conversation.
- When communicating digitally, I maintain the same levels of etiquette as I do in the real world.


Using digital tools for

Influencing international policy: Education Knowledge Service

What?

We propose that the government establishes an independent Education Knowledge Service (EKS) to co-ordinate development of a regularly updated, open access, online education resources bank supporting CPD for teachers, trainee teachers and teacher educators. This must be independently stored and protected in law so that the content cannot be changed or deleted by a current political party.

How and who?

The EKS would work with specialist subject/professional associations, research units (across all disciplines), government, businesses, commercial knowledge services and most importantly examination boards to ensure full coverage of topics relevant to teaching and open access for teachers to summaries of the latest research.

Why?

So that lesson content and teaching approaches are up to date and relevant for learners, employers and continuing education, thus bringing economic benefit to society and benefits to learners and teachers - potentially supporting teacher wellbeing, satisfaction
